Judge Asks AVLF to Help in Unusual Case

Tamara S. Caldas has represented plenty of tenants in civil disputes with landlords as the deputy director of the Atlanta Volunteer Lawyers Foundation. But serving as a victim advocate in a criminal case for almost 100 low-income tenants made homeless by a neglectful landlord is a first for her.

The Grove's manager, Harbor Management Inc.; Harbor's CEO, Steven J. Berkman; and its agents, Martin and Jenny Henderson, with criminal code violations, along with The Grove's ownership entity, South Hills Associates LLC.

"This was truly one of the worst situations that the code enforcement officers, perhaps the court-and certainly I-had ever seen," said Caldas. "These families needed legal advocates immediately."

"It's about as egregious a case as we've seen-and we've seen a lot in recent years with the recession," said Tony M. Phillips, Fulton County's assistant director for environmental enforcement.

Phillips said raw sewage was leaking into common areas and then tracked into the apartments. "In our view, they were not safe for human occupancy," he said, adding that a lot of children lived in the buildings. Phillips said several tenants have skin infections and asthma, which can be caused by sewage gas, fecal matter and mold.

## Other AVLF News



o David Johnson negotiated a 12-month stalking protective order. His client, and her daughter, were constantly watched and approached by an ex-boyfriend/ neighbor who had previously been arrested for being a Peeping Tom.

o AVLF volunteer attorney Raj Shah, of Parker, Hudson, Rainer & Dobbs, secured an illegally withheld security deposit for an AVLF client desperately in need of the funds to get back on her feet.

o AVLF volunteer attorney Tegra Watkins, of Watkins Legal LLC, obtained a \$3,325 settlement on behalf of an AVLF client whose security deposit was illegally withheld.

o Yvonne Williams of Sutherland negotiated a consent 12-month protective order with an inmate in the holding cell of the courtroom. Hopefully the TPO can end the violence that's continued to torment her and her child despite the parties' longstanding separation.

o Attorney Kevin Linder is on a roll. For the 4th week in a row, Kevin has secured a client a TPO. He managed to convey to the judge "classic symptoms of domestic violence", and carried the day for a Spanish-speaking-only woman who fled home after her husband chased her with a knife

o In their first TPO case, Stacey Lewis and Sara LeClerc secured not only a 12-Month Protective Order, but \$800 per month child support PLUS payment of the mortgage and utilities and a car for their client. Hopefully, her children will never have to try to keep daddy from punching and choking mommy

Eaves contacted AVLF after an emergency hearing on Aug. 12, attended by at least 50 evacuated tenants. Because of the magnitude of the case, Caldas enlisted Daniel J. Grossman to help.

Grossman already had a busy week lined up when Caldas called. He is still working on police compliance issues from the Atlanta Eagle settlement, after representing patrons and staff of the Midtown gay bar in a suit against the Atlanta Police Department over a 2009 raid, and has filed several new suits against the police over unlawful public strip searches.

"Tamara said she knew I take cases that make me angry. She said, 'Give me five minutes and I can make you angry,'" said Grossman.

He said he's represented other "victims of slumlords" pro bono. "When I heard human beings were making other human beings live in feces, I said, 'Sign me up.'"

- o AVLF volunteer Rob Elliott, of Troutman Sanders, secured the dismissal of an eviction filed against a low-income senior who came to Fulton County's new Self-Help Center and was assisted by AVLF's part-time attorney, Jennifer Hubbard.

## A Look at AVLF's Eviction Defense Program

Like so many tenants who contact AVLF, he expressed hopelessness and frustration with his living situation. Mr. Carlton had originally called our office for relief from the deplorable conditions in which he lived. He explained that he, his fiancée, and his two children began renting an apartment unit in January 2011. Since move-in, the client noticed the unit would flood each time it would rain, excessive mold and mildew throughout the apartment, and a large hole behind the stove, which enabled rats to enter the unit. To make matters worse, the children began experiencing respiratory problems that their pediatrician attributed to the mold spores in the unit.

Mr. Carlton had complained to his landlord about the unlivable conditions on numerous occasions to no avail. Like many of our low-income clients, Mr. Carlton expressed that he felt stuck, with no positive outcome in sight. As the apartment is in close proximity to his job and his children's school, he was willing to remain in the property, if the landlord would be willing to make the needed repairs. However, he could not afford to continue to put his family's health at risk, and give money to a landlord who had made no effort to make amends, other than to lean a tin baking sheet against the hole in the wall in an attempt to contain the rodent infestation. Like many of our clients, Mr. Carlton was faced with a difficult decision.

tenants had been evacuated by Fulton County Code Enforcement and Environmental Health Enforcement because their apartment buildings were flooded with raw sewage and contained dangerous amounts of mold. The families have received a total of more than \$100,000 in restitution payments from Mr. Berkman.

- o AVLF volunteer attorney John C. Bush, of Bryan Cave LLP, successfully negotiated a favorable resolution between an AVLF-client tenant and her landlord who were fighting over a security deposit and counterclaims.

- o AVLF volunteer Jennifer Smith, of David & Rosetti, settled a case to recover damages caused by her client's landlord's negligence and stopped collection activities and settled the debt of a client being pursued for medical-related debt that was not her responsibility.

- o Sarah Cash of AGG obtained a protective order for a client who was most recently pushed, choked, thrown on the ground and hit in the head by her husband in front of

The attorneys in the case entered a protective order by consent to keep not only mom safe, but the children as well.

o New AVLF volunteer attorney Kevin Linder won his first TPO case with AVLF, the first of 3 cases he has accepted in the course of 2 weeks. Kevin is shooting for 3 out of 3, and we are all hoping he maintains a perfect record!

o Our three newest volunteers are the perfect example of the diversity of the Domestic Violence Project's volunteer attorneys. One practices insurance litigation, one tax, and the other is in-house at a major

pay their rent, their medical bills, their child support.

This month, as the debate rages about the debt ceiling, we who advocate for the poor wonder if unemployment benefits, Medicaid, Social Security, Veterans benefits - those sources of income cited most commonly by our clients will be suspended or cut; we wonder how our partner non-profits will sustain another substantial reduction in funding from the Legal Services Corporation and how we will survive the decline in funding from nearly every source we rely upon to sustain our organization.

We feel personally challenged by the news that foreclosures and unemployment in metro Atlanta continue unabated, and that Georgia's consumer laws have not protected the most vulnerable families in our community from predatory and unethical behavior by more powerful interests. We see the deadly domestic violence incidents increasingly reported in the news and know that economic distress increases violent incidents in the home and workplace. We see the faces and hear the voices behind those statistics every day. It helps us understand that our clients are not exaggerating when they tell us that they feel like their lawyers are *actually* angels from heaven. Or, as a recent visitor to the Fulton County Self-Help Center said to AVLF's attorney there: "When I walked into your office this morning, I walked into a blessing." There is a level of need in our community right now that is hard to describe until you see the relief on someone's face when she realizes that she, at last, has her own lawyer.

We report on the successes of our volunteers in this newsletter each month to give credit to the outstanding lawyers in our community who step up to take on cases for people who would otherwise lose their personal property, their housing, their income, their safety without the benefit of legal counsel. We post the individual victories of our clients and their lawyers on Facebook, and tweet about them, because we want the whole legal community to experience each victory, large or small, for the value that it is in the life of someone who is struggling to support a family day after day, week after week. That \$1,500.00 judgment does make a difference. A huge difference. But these public reports of success also do something for the people who work to recruit, schedule, train, supervise, encourage and support the attorneys who handle the cases: AVLF's staff.

Pro bono work is only successful if there is an organization with experienced and committed staff available to support each client and each lawyer through their journey together. We are invested in each case, and when our volunteers are successful, we are successful. Each report of a successful outcome buoys our collective spirit and recommits us to our work, allowing us to
