## Call for Entry

A survey of current practices of the Canadian Members of the Surface Design Association



#### **Theme**

Canadian Surface Design Association textile artists are invited to submit work that reflects and interprets a diverse Canadian perspective. Selvedge to selvedge, raw edge or treated, traditional or experimental, we welcome the works that best capture and represent your unique current practices and signature style.

#### **Guidelines**

All Canadian members of the Surface Design Association are invited to participate. Artists must be current members of the Surface Design Association and Canadian citizens.

All work is to be created within the boundaries of a 16" wide by 28" long format. A 2" depth will be acceptable.

The top of the work needs to have a 2" 'sleeve' for hanging purposes. A flat metal rod (to be provided) will be inserted. The sleeve should stop 3/4" short of the side edges so that the rod will not show. The top edge of the sleeve should be placed 1" to 2" from the top of the work.

A label should be sewn on the back indicating artist's name, mailing address, materials and techniques. All work must be finished to a professional standard and be ready for hanging as per the guidelines stated above.

Accepted work is subject to final approval by the jurors' representative after the actual work arrives. Work that exceeds the size limitation and/or differs significantly from the digital image representing it will be ineligible for the exhibition and returned to the artist at the artist's expense.

The jurors will independently screen all images and make the preliminary selection of all work in the exhibition.

Entries will be evaluated on concept, design, technique, craftsmanship and creative exploration.

Work executed under classroom, educational guidance or supervision is not eligible.

Details about shipping instructions will be provided after jurying. Artists whose work is accepted will be required to contribute additional shipping and insurance fees.

All artwork must remain on display until the conclusion of the exhibition. An artists' bio booklet will accompany the show so that interested patrons may contact the artist directly.

#### **Submissions**

#### Images and submission forms are due October 1, 2014.

Entry fee: **\$40.00.** Maximum two entries per artist will be considered for jurying. Images submitted need to be sent as a jpeg image, image size 1024 x 768 pixels, resolution 300dpi. Each entry may be represented with one full view and one detail. Each image must be numbered and titled.
