Tour Pricing: Trip prices are based on the best available group rates. Unless a student registers and pays the price for double occupancy, all student tour prices are based on four or five occupants per room. Prices are guaranteed by School Tours of America for groups of thirty-five or more participants with the exception that fare increases from airlines, motor coaches, and/or travel via rail due to circumstances beyond the carrier's control (fuel surcharges, incremental taxes, etc.) will be added to the overall trip price.

Prices for Adults; Adults are automatically registered and priced at double occupancy. STA makes reasonable efforts to accommodate adult occupancy requests. Adults are charged for any change in the final occupancy status. The final invoice will reflect the fees due.

Any participant sent home will be sent at the sole expense of the parent/guardian. Registration/Payment: Complete the registration. Only one registrant per form. Mail registration payment and completed form (including parent/guardian signature) in the envelope provided. (Please do not send cash). A \$40 fee is charged for checks returned for any reason. Post-dated checks are not held.
