Collaborating with staff and key stakeholders from throughout the community, the Chief Community Investment Officer will facilitate the principles of collective impact to deliver successful outcomes that effect positive community change. The successful candidate will have a commitment to working effectively in a diverse community.

Responsibilities

Community Leadership

- Manage all aspects of the Foundation's community leadership role, including the evaluation and communication of impact.
- Collaborate with thought leaders to stage the annual 'Northern California Summit on Children and Youth'.
- Coordinate the trainings offered to nonprofits by RCF in collaboration with the Foundation Center.
- Work with the President and CEO to plan and implement the Community Leadership Institute.
- Serve as a thought partner for community initiatives external to RCF.
- Represent the Richmond Community Foundation on local coalitions, collaborations and at community events as appropriate.

Grantmaking

- Manage RCF's grants processes with the RCF Community Investment Committee of the Board.
- Provide recommendations to the President and CEO and the Chief Development Officer on opportunities for grants from Advised Funds and other donors.
