The Founders clearly stated their intentions for a limited government, yet some amendments have been abused by congress to allow for the unrestrained growth of federal control and spending. No congress has been successful at reducing the size of government. Each state must be viewed as sovereign by the federal government and must not be compelled to sacrifice for the needs of another state -so that taxation is ?uniform throughout the United States?.
