SUMMARY

This lawsuit specifically targets two portions of the bill: the assault weapons ban (AWB) and the ban on so-called "high-capacity magazines" (HCM's).

COUNTS

- 1. The prohibition on commonly possessed firearms violates the 2nd Amendment
- 2. The prohibition on commonly possessed magazines violates the 2nd Amendment
- 3. The prohibitions also deny those who possess these firearms and magazines equal protection of the laws
- 4. Many provisions of the law are vague, fail to give appropriate notice, and violate due process

Handgun Qualification License

Doe, et al. v. O'Malley, et al. 13-CV-2861 U.S. District Court, MD (Baltimore)

PARTIES

Defendants: Martin O'Malley, Douglas Gansler, Col. Marcus Brown, and Maryland State Police

SUMMARY

This lawsuit attacks the constitutionality of the requirement to obtain a handgun qualification license (HQL) and the way in which the Maryland State Police have been attempting to implement it.

COUNTS

- 1. The requirement violates the 2nd amendment by creating a de facto ban on handgun acquisition as of Oct. 1st
- 2. The opposing statements by the Attorney General and the Maryland State Police regarding whether an HQL is necessary to receive a handgun purchased lawfully before Oct. 1st have led to mass confusion and exposed plaintiffs to potential criminal prosecution
