2. All Units must be decorated with exception of Public Officials
3. All Units must be in Line-up by 6:00 p.m.
4. NO CANDY may be thrown from a moving object but can be passed out by walkers.
5. Your Position Line-up Number will be given out at the MANDATORY pre-parade safety meeting.
6. Parade Line-up starts @ Collins & Alsobrook Street – heads North on Collins to Reynolds Street – right on Reynolds Street. The parade will end by the Plant City Court House.
