

NAR ETHICS TRAINING

Effective as of January 1, 2001, existing REALTOR® members are required to complete a minimum of 2.5 hours of ethics training within four-year cycles. The current four-year cycle will end Dec. 31, 2016.

Any training offered pursuant to this requirement must meet the learning objectives and minimum criteria established by the NATIONAL ASSOCIATION OF REALTORS®. Our elective CE course not only provides you with 4 hours of elective CE credit toward your real estate license renewal but also meets the objectives and criteria of NAR for the existing REALTOR® quadrennial ethics training.

Failure to complete the required periodic ethics training shall be considered a violation of a membership duty and will result in suspension of membership for the first two months (January and February) of the year following the end of any four (4) year cycle or until the requirement is met, whichever occurs sooner. On March 1 of that year, the membership of a member who is still suspended as of that date will be automatically terminated.
