PURPOSE:

ASID Carolinas honors those within our Chapter who inspire us with exemplary service to the Chapter and our profession. We are looking for individuals, Industry Partners and institutions who qualify for the **EDUCATION** AWARD, **MEDIA** AWARD, **INDUSTRY PARTNER** AWARD, CAROLINAS **CHAPTER** AWARD AND the **DORA GRAY DISTINGUISHED DESIGNER** AWARD.

DEADLINE:

All nominating and supporting letters for Awards are due by 5:00 PM on Friday, MAY 24TH, 2014. All materials received after that time will be ineligible for consideration.

NOMINATION PROCESS:

- **HOW TO SUBMIT NOMINATIONS:**
 - The nominations are to be made by letter to the Awards Chair of ASID Carolinas Chapter from any current ASID Member.
 - You are welcome to email your nomination letter and supporting letters, but they MUST be in ONE (1) single email per nominee.

PLEASE NOTE:

- Only ONE (1) supporting letter for any nominee may be submitted from the nominee's company or firm.
- All other required supporting letters MUST be submitted from persons NOT employed by or affiliated in any way with said nominee.

JUDGING CRITERIA:

The Judges will select from your recommendations ONLY.

Please honor our members by carefully responding to this request. Remember, <u>you</u> may be nominated by someone else, so take time to nominate those who deserve recognition of ASID Carolinas Chapter.

IMPORTANT TO NOTE

Only <u>ONE</u> (1) hard copy of the Chapter Recognition Award will be presented in each Category, <u>regardless</u> of whether the winner is part of a group or a single <u>individual</u>.

If a winning group wishes to obtain multiple hard copies of the award, each additional Award Certificate requires payment of \$50.00 to the Chapter at the time of Award notification.

EDUCATION AWARD

PURPOSE:

"Will recognize and honor an individual, organization or school who has made an outstanding contribution in Design Education of major or long term significance providing Chapter-wide impact. The Award may be given to an individual or organization based upon a specific action or cumulative service."

NOMINATION CRITERIA:

- This Award is designed to:
 - Recognize a significant <u>professional</u> contribution to interior design education in the Chapter. The person or group shall have performed long term acts of outstanding professional significance, preferably with Chapter-wide impact.
 - Highlight creative and intellectual contributions to design education through teaching, research, administration or writing.

Nominees must demonstrate a lasting impact and inspiration to colleagues,

students and the interior design profession.

> Eligibility:

- A person (s)
- o An educator
- o A school
- o An industry, or
- An organization

The candidates may be ASID members or non-members and/or groups or organizations.

- MUST be nominated in WRITING by one member with DETAILED documentation of the nominee's specific action or their cumulative service
- o **MUST** be accompanied by **TWO** (2) to **THREE** (3) supporting members' written recommendation letters, only one of which may come from nominees' firm or company.



MEDIA AWARD

PURPOSE:

"Will recognize and honor an individual, organization, publication, or business which has made an outstanding contribution of professional significance, providing Chapter-wide impact through the Media to promote the Profession of Interior Design and ASID. The Award may be given to an individual or organization based upon a specific action cumulative service."

NOMINATION CRITERIA:

- This Award is designed to:
 - o Recognize exceptional support and/or a significant professional contribution by a member(s) of the media to promote the profession of Interior Design.
 - The nominated entity must be actively working to promote the professionalism of Interior Design and especially ASID within the media.

> Eligibility:

- An individual
- o Multiple individuals
- o A publication
- o An industry, or
- An organization

The candidates may be ASID members, ASID IP Members or non-members and/or groups or organizations.

- MUST be nominated in WRITING by one (1) ASID or IP member with DETAILED documentation of their specific action or their cumulative service
- MUST be accompanied by TWO (2) to THREE (3) supporting members' letters of recommendations, only one of which may be written by a person affiliated with the nominee.



INDUSTRY PARTNER AWARD

PURPOSE:

"Will recognize and honor an individual Industry Partner or Company who has made an outstanding contribution of professional significance providing Chapter-wide impact through the promotion of the Profession of Interior Design, particularly ASID. The Award may be given to the individual or to the organization based upon a specific action or cumulative service."

NOMINATION CRITERIA:

This Award is designed to:

- Recognize the significant professional contribution by an Industry Partner member or entire Company member of ASID, which helps to promote and advance the profession of Interior Design and especially ASID.
- This Award may be given to the individual or to the organization based upon a specific action or cumulative service, and must show dedication to the profession.

Eligibility:

- o An Industry Partner member participating actively in the activities of ASID Carolinas
- o Makes conspicuous contributions that advance the Chapter, and
- Provide exemplary service to the Interior Design profession

- Nominee MUST be an Industry Partner in good standing
- MUST be nominated in WRITING by one (1) ASID or IP member with DETAILED
 documentation of their specific action or their cumulative service, citing professional
 achievements, outstanding leadership contributions, social concerns, as addressed by the
 nominee
- MUST be accompanied by TWO (2) to THREE (3) supporting members' written recommendation letters, only one of which may be affiliated with nominee's company or firm.
 - It is preferable that recommendations come from both ASID and IP members.



ASID CAROLINAS CHAPTER AWARD

PURPOSE:

"Will recognize and honor a member or non-member who had made an outstanding volunteer contribution of significance to the community over a period of years. In addition, this honoree has demonstrated a positive public reflection of the Profession of Interior Design and especially of ASID to the community at large. The Award may be given to an individual or organization based upon a specific action or cumulative service."

NOMINATION CRITERIA:

This Award is designed to:

- o Recognize outstanding volunteer service to the community over a period of years of significant Chapter-wide impact.
- In addition, the nominee should show attention to social concerns within the interior design profession and express creative, innovative concepts that have advanced the profession.
- o This Award is also meant to take into consideration service to the Carolinas Chapter and to recognize the relationship between the community as a whole and the volunteer as an ambassador for ASID.

Eligibility:

- o An individual
- Multiple individuals
- o An industry, or
- An organization

The candidates may be ASID members or non-members and/or groups or organizations.

- MUST be nominated in WRITING by one (1) ASID or IP member with DETAILED documentation of their specific action or their cumulative service
- o **MUST** be accompanied by **TWO** (2) to **THREE** (3) supporting members' letters of recommendations, only one of which may come from someone employed by or affiliated with the nominee.
- o **NOTE**: Current Chapter Presidents are **INELIGIBLE** for this award



ASID CAROLINAS DORA GRAY DISTINGUSHED DESIGNER AWARD

PURPOSE:

"Will recognize and honor ASID Carolinas designer who had made continuous outstanding contributions toward achieving ASID's goal of excellence. This Award is based on the designer's professional achievements demonstrating their creative and innovative concepts, as well as service to their community, and to ASID Carolinas Chapter."

NOMINATION CRITERIA:

- This Award is designed to:
 - Recognize an ASID professional member who exemplifies a commitment to the profession as demonstrated by a significant, high quality body of work representing excellence in interior design.
 - o This Award is also based on the candidate's professional achievements as exemplified by their design work over their career, and by their contributions to society and to the Chapter.

This Award is based on the National ASID Designer of Distinction Award.

It is the most important Award that the Chapter

can convey on one of its members.

> Eligibility:

- o An individual who MUST:
 - (1) Have been widely published and/or have received Design Awards.
 - (2) Be active in their community and in the Chapter with demonstrable accomplishments of value
 - (3) Demonstrate ASID's goals of excellence.
 - (4) Be an ASID Professional member in good standing for at least ten years.

- o **MUST** be nominated in **WRITING** by one (1) ASID or IP member **with DETAILED documentation of** the nominee's Awards, specific actions and their cumulative service
- o **MUST** be accompanied by **THREE (3)** supporting members' recommendation letters, only one of which may come from a person affiliated or employed by the nominee.
