## ◆ NEIGHBOR DISPUTE NOT SO NEIGHBORLY

A dispute between neighbors sent a Griffin Road man to jail Tuesday afternoon. Bartow County Sheriff's Deputies were called to 429 Griffin Rd. after a woman said her dog got out and ran across the street to Willie Bryant's residence. She told deputies as she approached his residence to get her dog he yelled "I'll kill this dog and you if you two come over here." She told officers he held a piece of concrete and acted like he was going to throw it at her. She said he yelled several obscenities. Bryant claimed the dog attacked his dog and he denied cursing the neighbor. However, witnesses said they heard the entire incident. Bryant, 65, is charged with terroristic threats, simple assault, disorderly conduct and going inside a guardline with a weapon.

## ◆ LAWNMOWER SENDS MAN TO JAIL

A man riding a lawnmower got himself in trouble with the law Tuesday evening. Bartow County Sheriff's Deputies were called to 1120 Richards Rd., Rydal, after Lester Lee Johnston, 82, allegedly tried to hit his girlfriend with a riding lawnmower. His girlfriend said she was able to get out of the way but it came within a foot of hitting her. She then said he drove the mower to the horse pasture and chased the horses. His girlfriend said Lester gets angry easily when he drinks. Lester told deputies that the blades on the lawnmower weren't on. Sheriff's reports said due to Lester assaulting her with a weapon (lawn mower) Lester is charged with aggravated assault (FVA).

◆ The Catoosa Co. Sheriff's Office said on Friday, Catherine Goins, 37, Hixson, Tennessee, shot Natalia Roberts, 30, Lafayette, at her home. Goins lured Roberts to the house under the pretense of giving her some clothes for her baby. Goins shot Roberts on the back of the head. Goins then took Roberts children, a 3 week old baby and a 3 year old. Officials said Goins most recent boyfriend had recently left her after learning she had been lying to him about being pregnant. Goins is charged with murder.

• U.S. warplanes bombed the Islamic State of Iraq and Syria (ISIS)again, the Pentagon confirmed late Wednesday afternoon. The strikes were against a dozen ISIS targets with five of the strikes being carried out by the U.S. and seven by Arab allies. U.S. Central Command said in a statement the results of the strikes on the refineries were still being assessed but the initial indications are that "the strikes were successful."

• The widow of NFL player Paul Oliver is suing the National Football League. Paul Oliver was 29 years old when he shot himself last year. His widow is suing the league, the Chargers, Saints and helmet manufacturers. She said Oliver's suicide was the direct result of injuries, depression and emotional suffering from football head trauma and concussions.
