- 0102.00:** live bovine animals
- 0103.00:** live swine
- 0201.00:** meat of bovine animals, fresh or chilled
- 0202.00:** meat of bovine animals, frozen
- 0203.00:** meat of swine, fresh, chilled or frozen
- 0207.13.10:** cut of offal, fresh or chilled, of spent fowl
- 0406.90:** cheese, not including the following: fresh (unripened or uncured) cheese, whey cheese or curd; grated or powdered; processed cheese; blue-veined cheese or cheese containing veins produce be *Penicillium roqueforti*
- 0808.10:** apples, fresh
- 0809.29:** cherries, other than sour cherries (*Prounus cerasus*)
- 0812.10:** cherries, provisionally preserved (unsuitable in the state for immediate consumption)
- 1005.00:** corn (maize)
- 1006.30:** semi-milled or wholly milled rice, whether or note polished or glazed
- 1602.32.11:** prepared or preserved-prepared meals of spent fowl; prepared meals of specially defined mixtures
- 1602.32.92:** prepared of preserved-specially defined mixtures, other than in cans or glass jars; spent fowl other than in cans or glass jars
- 1602.49:** prepared or preserved swine cuts, other than ham and cuts thereof; other than shoulder and cuts thereof
- 1602.50:** prepared or preserved meat of bovine animals
- 1702.20:** maple sugar and maple syrup
- 1702.40:** glucose and glucose syrup, containing in the dry state at least 20 percent but less than 50 percent by weight of fructose, excluding invert sugar
- 1702.20:** certain fructose and fructose syrup, containing in the dry state more than 50 percent by weight of fructose, excluding invert sugar
- 1806.20:** chocolate and other food preparations containing cocoa-preparations in blocks, slabs or bars weighing more than 2 kg or in liquid, paste, powder, granular or other bulk form in containers or immediate packings, of a content exceeding 2 kg
- 1806.90:** other chocolate and other food preparations containing cocoa-ice cream mix or ice milk mix; chocolates; chocolate coated nuts and other confectionery
- 1902.00:** pasta, whether or not cooked or stuffed (with meat or other substances) or otherwise prepared, such as spaghetti, macaroni, noodles, lasagna, gnocchi, ravioli, cannelloni; couscous, whether or not prepared
- 1904.00:** prepared foods obtained by the swelling or roasting of cereals or cereal products (for example, corn flakes); cereals (other than maize in grain form or in the form of flakes or other worked grains (except flour, groats and meal), pre-cooked or otherwise prepared, not elsewhere specified or included
- 1905.00:** bread, pastry, cakes, biscuits and other bakers' wares, whether or not containing cocoa; communion wafers, empty cachets of a kind suitable for pharmaceutical use, sealing wafers, rice paper and similar products
- 2004.10:** certain potatoes, prepared or preserved otherwise than by vinegar or acetic acid, frozen

- 2009.11:** frozen orange juice
- 2103.20:** tomato ketchup and other tomato sauces
- 2204.00:** wine of fresh grapes, including fortified wines; certain grape must
- 2207.20:** ethyl alcohol and other spirits, denatured, of any strength
- 2940.00:** certain sugars, chemically pure, other than sucrose, lactose, maltose, glucose and fructose; sugar ethers, sugar acetals and sugar esters, and their salts
- 3504.00:** peptones and their derivatives; other protein substances and their derivatives, not elsewhere specified or included; hide powder, whether or not chromed
- 7113.00:** articles of jewelry and parts thereof, of precious metal or of metal clad with precious metal
- 7306.40:** certain tubes, pipes and hollow profiles, welded, of circular cross-section, of stainless steel
- 7321.90:** parts for non-electric heating appliances
- 7326.11:** grinding balls and similar articles for mills, forged or stamped, but not further worked, of iron or steel
- 9401.30:** swivel seats with variable height adjustment
- 9403.30:** wooden furniture of a kind used in offices
- 9404.29:** mattresses of materials other than cellular rubber or plastics, whether or not covered
