### County Continues Flood Clean Up and Data Collection

The Douglas County Board of Commissioners requested a State of Emergency due to the cumulative series of flash floods that have taken place since July 20, 2014, in Douglas County.

"We realize this storm created some serious problems for our residents and we have set all regular road projects aside, to make cleaning up this flood damage our main priority," said Carl Ruschmeyer, Douglas County Public Works Director. "In addition, County staff is meeting with Homeowners Associations and residents to address questions and concerns."

The floods caused damage to many residents' driveways, culverts, structures, and landscaping. The Douglas County engineering department fielded a large volume of calls with residents inquiring about permits and when a permit is needed.

"If damage occurred to previously permitted driveway connection or culvert or the driveway was washed out, the resident may repair or replace the structure without obtaining a new permit," said County Engineer Erik Nilssen. "If you wish to construct a new or previously not permitted driveway crossing or culvert in the right of way a new encroachment permit must be obtained from the Community Development Department.

The permit requires a dimensioned site plan of the property indicating the location of the proposed improvement. An encroachment permit can generally be reviewed and approved within two days."

The night of the Fish Springs flood, National Weather Service reported that the Doppler radar indicated an inch of rain had fallen at the top of Pine Nut Creek in 45 minutes.

According to the weather service's tables that would come close to being a 200-year flood, which would see 1.11 inches of rain over 30 minutes.

Douglas County Interim Manager Larry Werener said the weather pattern that resulted in flooding across the county is remarkable. "None of us have ever seen this before," he said. "We were hit by an extraordinary storm. There's no way we could afford to design structures to withstand that."

Exacerbating the flooding was the large amount of sediment included in the July 20 flood.

"The mud flow was a different sort of animal," he said. "Every time it hit a culvert it would plug it up and then jump over the road and do it again the next time."

A State damage assessment team visited over 75 properties and they toured Fish Springs and Johnson Lane to gather information about the level of damage from flooding in Douglas County.

Team members also contacted residents who used the county's flood hotline or email.

Once the assessment team finishes its report, it will be reviewed by the state and then sent to the governor, who will determine whether the damage qualifies the county for a state declaration.

If approved at the state level, the County would be eligible to apply for financial assistance from the state disaster relief account. However, those funds are only available to help rebuild public infrastructure. Landscaping and yard damage are not eligible under FEMA programs or the State's Disaster Relief Account (DRA). FEMA and the State Disaster Relief funds will generally not pay for debris removal from private land.

### Douglas County Welcomes Nevada Filtration System
