You must reside in the territory served by AAA East Central (Club 215). For current members the discount represents a savings of \$7.00 for basic membership (normally \$49.00). New members will save an additional \$10.00 off new membership dues (normally \$59) because AAA is waiving the \$10 enrollment fee.

The annual open enrollment period ends October 11, 2013 and the enrollment form below should be completed and returned to my office by that date. ***If you are already enrolled through this group program, your renewal is automatic and you do not need to complete an enrollment form. Payroll deductions will be made on November 1, 2013.***

If you are already a member of AAA East Central (Club 215), AAA will simply extend your expiration date to November 30, 2014. You pay a pro-rated amount based on the discounted rates, and retain the full benefit of the number of years you have been a valued member of AAA.
