

Nevada Office of Grant Management, Research and Planning

Facilitating Grants: The Nevada Grant Office provides a full-range of grant support to include: the identification of funding opportunities, grant writing and editing, developing collaborations, coordinating grant activities with internal and external partners, obtaining and developing data matrices, budget assistance, grant project management as well as technical assistance with the grants.gov system or other grant management systems.

Federal Compliance: To ensure Nevada is compliant with federally mandated activities such as Federal Funding Accountability and Transparency Act (FFATA) and the Digital Accountability and Transparency Act (DATA), the Grant Office maintains close relationships with federal partners and updates Nevada agencies on regularly changing regulations and reporting requirements. In addition, the Grant Office works with the federal delegation on grant related legislation and funding.

Reporting and Data: Ensure Nevada is submitting mandated and accurate State and federal grant information. Make data sources available for agencies to utilize in the grant process.

Training: To develop, provide and coordinate grant-related training workshops and resources, specific to agencies, and to provide the required tools and knowledge base for effective competition in the grant arena.

Grant User Meetings: Facilitate Grant User meetings with state agency representatives to provide a "community of peers forum" to develop and share demonstrated best practices and continuity between agencies on policies and procedures.

Single Point of Contact (SPOC): State agencies are required by NRS 232.225 and Policy Directive #D-2014-03 to inform the Nevada Grant Office of each agencies' intent to submit for a grant; provide a copy of the application; and provide a copy of the Notice of Grant Award or denial of the funding. Executive Order: To foster intergovernmental partnerships and strengthen federalism by relying on state and local processes for the coordination and review of proposed federal assistance and development, Executive Order 12372, "Intergovernmental Review of Federal Programs," was issued. This requires coordination with the Nevada Grant Office for federal grant projects.
