Fred Lee has the enviable distinction of having been both a senior vice president of a major medical center and a cast member at Disney University. At Disney he helped develop and facilitate Disney's healthcare version of its 3-day seminar, Disney's Approach to Quality Service, and its newest seminar on Customer Loyalty. He authored the healthcare best seller, *If Disney Ran Your Hospital: 9 ½ Things You Would Do Differently*, which was awarded the 2005 Book of the Year from the American College of Healthcare Executives.

The conference will also feature three distinct educational tracks [Revenue Cycle Management, Payment and Reimbursement, and Leadership]. Each track will provide 5 educational programs dealing with the most pressing current issues in health care
