Dear Senator Corbett:

Under the Lanterman Act, people with developmental disabilities are entitled to services and support that enable them to live a more independent and normal life. More than 260,000 individuals with developmental disabilities receive services from California Regional Centers and their 65,000 service providers.

Inadequate service provider rates have hindered California's ability to meet our basic obligations to Californians with developmental disabilities. Provider rates for residential and day programs lag far behind inflation making it difficult for many service providers to remain open.

The gap between rates and inflation continues to grow. Since July 2000, the Consumer Price Index has increased 36.6%. Yet, residential care facilities and day program providers received only minimal rate increases during the same time period. One increase was granted in 2006 and then reversed in 2008 with other deep cuts to total more than \$1 billion cut from the community system in the last 5 years. Considering inflation and cuts, rates have virtually been frozen since 1998.

I respectfully request the Senate Budget Subcommittee 3 direct the Department of Developmental Services (DDS) to analyze the general fund cost to update rates from the time of the reductions, adjusted for inflation. Analysis should be broken into the following areas:

- Community Care Facilities
- Intermediate Care Facilities
- Supportive Living Services
- Day Programs
- Employment Programs

BUDGET AND FISCAL REVIEW SUBCOMMITTEE #2 ON RESOURCES, ENVIRONMENTAL PROTECTION, ENERGY AND TRANSPORTATION CHAIR I realize that the cost of total restoration is outside our reach today. However, we must begin to make in-roads to address the gap. There are 260,000 consumers living in the community that need our help and have waited five years for us to respond. That is why, I also request the Subcommittee direct DDS to analyze the general fund cost of an across-the-board increase of 5% to both elements of the community side of the DDS Budget (Item 4300) -- 5% for regional center operations and 5% for purchase of services.

Understanding the impact of inadequate rates is the first step in a broader discussion as Legislators consider modest investments to restore lost funding for human, medical, and mental health services.

In addition to fiscal analysis, I've attached a budget proposal from the Lanterman Coalition for your consideration. The proposal puts forth eight recommendations, which includes modernizing DDS' arduous based rate model and removes failed policies that were intended to cut state costs, but have only served to increase providers' administrative overhead.

I believe these recommendations will increase DDS' effectiveness and outcomes in fulfilling the promise of the Lanterman Act and should be explored further by the Senate Budget Subcommittee 3.
