Thursday, September 25th at New Hampshire Fire Academy**

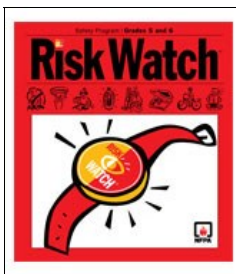

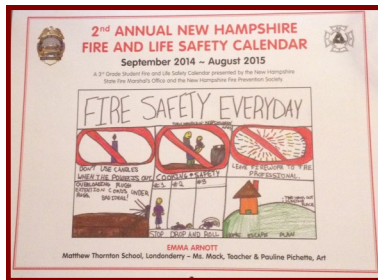
The main focus of the symposium will be to discuss the role and responsibilities of the Fire Chief as applicable by NH Statute. The forum will have guest speakers that will discuss the publication **New Hampshire Fire Laws Annotated**, also known as the Red Book/LexisNexis **Manual**. This particular publication is the "governing book" that clearly defines **by statute**, the authority of a Fire Chief. It is apparent that many NH Fire Chiefs, Governing Boards and Town/Municipal Officials are not entirely familiar with statutory responsibilities as applicable under NH Fire Law. This symposium will provide attendees with a clearer understanding of those laws. At the conclusion of the symposium, **each agency represented** will receive an updated version of NH Fire Laws Annotated for their reference at **no cost**.

We encourage all **Fire Chiefs** and **Chief Officers**, to attend this very important event. In addition to the dissemination of regulatory information, the symposium will provide excellent networking opportunities for fire departments of all size and scope. Breakfast and lunch will be provided and there is no cost to attend. 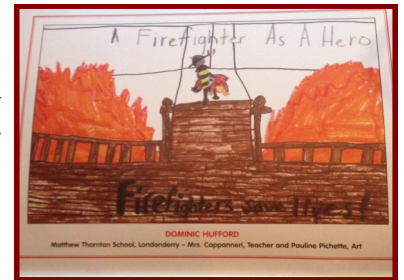
