MAPCS Committee Descriptions

Membership Committee

MAPCS recognizes that the most effective marketing tool for membership growth is a peer to peer recruitment and retention program led by volunteer members.



The MAPCS Membership Committee develops strategic plans and sets recruitment and retention goals each year.

Government Affairs Committee

The MAPCS Government Affairs Committee is responsible for representing and protecting the private career school's legislative interests.



Recently MAPCS worked to amend the regulations proposed by Attorney General Martha Coakley and the Division of Professional Licensure (DPL).

MAPCS members believe that the regulations do not simplify or improve the process through which students select their institutions, but rather cause greater confusion. MAPCS worked to amend the regulations in order to improve student protections.

The Attorney General's regulations were promulgated on June 20, 2014.

The MAPCS Government Affairs Committee continues to monitor the DPL regulatory process and review legislation that can impact the private career school sector.

Board of Directors

Members of the MAPCS Board of Directors are responsible for ensuring that the organization stays on track in meeting the organization's mission, services, policies and programs.



Board members have a fiduciary responsibility to review and approve the association's budget and financial strategy.

They approve major policies, serve on committees or task forces, take on special assignments and promote the association to others in the private career school industry.

Education Committee

The MAPCS Education Committee is responsible for determining the membership's educational needs and implementing programs to meet those specific needs.



The Education Committee also plans the MAPCS Annual Conference, which features numerous educational workshops and exhibits, as well as networking and constructive interaction with public officials, vendors, faculty, school owners and administrators.
