WHAT DOES A COMMUNITY INVESTMENT TEAM DO?

Community Investment Team volunteers set the vision, identify the issues and develop long-term community level strategies and outcomes that address the issues identified by the specified team in Laramie County. Each team has chair and co-chair that guides the team's work. Community Investment Team volunteers are responsible for:

- **Setting a Shared Vision**
- **Selecting/Prioritizing Target Issues**
- **Establishing Long-Term Community Level Outcomes**
- **Identifying Obstacles**
- **Create & Review the Request for Proposals**

WHAT IS THE TIME COMMITMENT?

Each team meets as needed throughout the year to continue work pertaining to their particular focus. As the team approaches the time for the next two year funding cycle, volunteer meetings may need to take place more frequently at the direction of the team chair. A projected timeline outlining a team member's time commitment for a given funding cycle is available for your review.
