

# **Award Descriptions**

## **Business Excellence Award**

Description: Honor one business in the DCR Chamber for their outstanding successes in 2013-14. This company is one that has made an impact in their market and has experienced consecutive periods of financial growth.

Eligibility: All businesses are eligible for this award and may nominate themselves. Must be a current DCR Chamber member and have been in business for at least 10 years.

Criteria: Nominees should exhibit success in a variety of ways, such as increase in employees, ability to retain talent, taken and prevailed risks, recognized as a leader in their industry or marketplace, expanded, or consecutive periods of financial growth.

# **Community Leadership Award**

Description: Honor one business in the DCR Chamber for their remarkable contributions and actions in the community that have not only improved the quality of life, but have made a difference in the lives of their employees as well.

Eligibility: Non-Profits are not eligible to receive the award. All for-profit businesses that are a current DCR Chamber member are eligible and may nominate themselves.

Criteria: Nominees should demonstrate a commitment to the community, region and their employees by identifying activities and organizational support performed in 2013-14. Activities could include employee volunteerism or partnership with a non-profit or community organization.

## **Small Business of the Year Award**

Description: Honor one business in the DCR Chamber for their entrepreneurial spirit, creative business strategies and contributions to the community.

Eligibility: All for-profit businesses that are a current DCR Chamber member, have fewer than 50 employees and have been in business for at least 3 years are eligible for this award. Businesses may nominate themselves.

Criteria: Nominees should identify their growth strategies and outcomes, how they support and foster growth of their company's workforce, retain talent and demonstrate engagement with the community.

## Non-Profit of the Year Award

Description: Honor one non-profit organization in the DCR Chamber for their successful service delivery, volunteer engagement and creative development strategies.

Eligibility: All non-profit organizations that are a current DCR Chamber member are eligible and may nominate themselves.

Criteria: Nominees should identify the types of direct services provided, how many individuals have they impacted and in what ways, creativity in delivery of services, successful development and donor recruitment efforts, and strategies that guarantee the organizations stability and sustainability.

# **Woman/Minority Owned Business Award**

Description: Honor one business in the DCR Chamber that is owned by either a woman or minority and has demonstrated creative business strategies.

Eligibility: Non-Profits are not eligible to receive the award. All for-profit businesses that are a current DCR Chamber member and are owned by a woman or minority are eligible and may nominate themselves.

Criteria: Nominees should identify how they are recognized as a leader in their industry and with their peers, means by which they support and encourage the growth of their workforce and demonstrate an ability to take and overcome risks.
