## **Rules Of The Field**

## We are Field Paint Only!!!!!

## Safety

- Goggles on at all times while on the playing field. NO EXCEPTIONS!!!!
  If you remove your goggles while on the field, you will be DONE FOR THE DAY!
- Barrel plugs in at all times while in the staging area. CONTINUED DISREGARD AND YOU WILL BE DONE FOR THE DAY!!

## Referees

- All referees are experienced players who know the game well. Pay attention.
- Referees calls are final.
- If you have a problem with a judgment that a referee makes, talk to the head referee, or the field manager to work things out.
- Back-talk or attitude given to the referees will not be tolerated.
- Don't shoot the referees.
- If a referee is in your line of fire, just ask them to move.

#### Rules

- No carrying the bunkers or the parts.
- No wiping off paint hits while in the field.
- No talking while exiting the field. DEAD MEN DON'T TALK.
- No coaching from the sidelines.
- Exit the field only from the tape lines through the staging area.
- No shooting towards the white house or storage sheds.
- No using referees for cover.
- No foul language.
- No continuous dry firing in the staging area.

#### Paint-checks

- Call "PAINT CHECK" for a referee to check you if you don't see an obvious hit.
- When a referee is checking a player, that player is considered neutral. Don't shoot at a neutral player.
- If you get hit and call "OUT" you are out, instead call "PAINT CHECK" so you can be inspected.

#### Close range

• Offer opponents the chance to surrender if you are closer than 15 feet.

## Exiting the field

- If you have been eliminated, raise your gun and arm over your head and go to the closest trail or sideline to exit the field.
- Exit the field as quickly as possible to avoid slowing down the game.
- Put your BARREL COVER on before entering the staging area.

### PAINTBALL SAFETY RULES

I will sign an APPLICATION TO PLAY form prior to the day or session of activity, and I acknowledge that this agreement is binding.

I will follow all special instructions (including these rules), which the game operator or their agents may give prior to each game.

I will read and obey all signs posted regarding goggles and barrel plugs.

I will adjust the velocity of my paint gun to shoot below the posted maximum for each game I play. (Paintball guns will be provided for each participant).

Every time I play I will wear approved goggles and other required safety equipment at all times within the playing, chronograph, and target areas. (Goggles and helmets will be provided at no additional charge).

I understand that I will be ejected from the game for unauthorized removal of my goggles within the playing, chronograph, or target areas.

I will keep my paintball gun barrel plugged or covered at all times while outside of the playing, chronograph, and target areas.

I will use only paintball equipment approved by the APL and the field operator or sponsor.

I will not use illegal drugs or alcohol of any type before or during paintball game activities.

I will abide by all decisions of the referees and playing field officials.

I will stay within the playing field boundaries at all times while I am playing in paintball games.

I will do no tree climbing or other dangerous or hazardous activities while playing paintball.

Should I see or believe that another player might be injured, I will immediately stop the game and assist that player.

I will assist the field operator or sponsor in keeping the playing field boundaries well marked.

I am playing this game for fun and will refrain from foul or abusive language, and will not engage in any arguments or physical contact of any kind.

I will make myself familiar with any safety or first aid equipment available in the event of an accident.

I agree to abide by all applicable federal, state, and local laws governing the playing of this sport.

# APPLICATION TO PLAY

#### THIS IS A RELEASE OF LIABILITY FORM—READ BEFORE SIGNING REDEMPTION MINISTRIES, EASTERN VIRGINIA CONFERENCE

If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest official as soon as practical; and,

4.I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS FROM LIABILITY REDEMPTION MINISTRIES (the operators of premises used to conduct the paintball activities), their officers, officials, agents and/or employees ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, except that which is the results of gross negligence and/or wanton misconduct.
