



The following instructions & requirements are in force for all who wish to participate in this ATF Regulated Auction. Please feel free to contact laura@bclauktion.com with any questions or concerns you may have. Thank you!

In order to receive approval to bid in the auction you must meet the following requirements:

- 1) Valid, Current & Signed ATF License/Permit for Fireworks
- 2) Notice of Clearance or Letter of Clearance

Please email these documents to sueh@globalpyro.com or fax to 636-274-0883 & upon receipt and approval, you will be notified via email your approval to begin placing bids.

Important Information pertaining to the Removal of Items Purchased:

ATF Regulated Items will only be released to the following personnel:

- Listed ATF License Holders
- Cleared Employee
- Possessors or a Certified List of Representatives or Agents Authorized to Pick-Up Explosive Materials.

GPS will complete all Dangerous Goods Forms & the Bill of Lading for Hazardous Material, however:

Bidder is Responsible for preparing their own separation wall for Shipment, if required, & for bringing all tools and labor required for a safe removal.

**GPS will not have any materials or tools onsite to assist with this DOT Requirement.*

Requirement for the Trucking/Shipping Contractors:

Must be a DOT/CDL Driver with HAZ-MAT Endorsement if transporting Explosives.

Instructions for Scheduling your Item Pick-Up Time:

All pick-ups must be scheduled in advance with Sue at GPS by emailing sueh@globalpyro.com, the day after the auction closes with the following information:

- 1) Your Bidder # in Subject Line
- 2) Your requested Date to pick-up.
- 3) State how the Explosives will be Transported, Customer Ship or Commercial Ship
- 4) Your Name and Telephone Number

Directions for Everyone entering the GPS Premises:

1. Parking is only allowed in the field.
2. Enter the Main Office to Check-In, obtain your Paid Invoice & receive any important directions.
3. Smoking & Firearms are NOT PERMITTED anywhere on the premises.

4. Restrooms are located at the Main Office, however, there aren't any restaurants nearby, so please plan accordingly.

From Interstate 55

Take I-55 to Highway 270 west. Take Gravois Road south towards the City of Fenton (not Old Gravois Road), also known as Highway 30. Take Highway 30 for 27 miles to Highway Y. Make a left, follow for LESS than a mile and make a left into our facility. There will be two flagpoles, a brown fence, and a mobile home at the entrance. Our office looks like a brown brick ranch house that sits a little back from Highway Y.

*Please note your last 7 miles of your 27mile trip is on two-lane road.

From Interstate 44

Take I-44E to Highway 270 east (or south), which is less than a mile or so when you get on I-44E. Take 270 east or south to Gravois Road, which is the first exit after you get on 270. Take Gravois Road/Highway 30 to the right, which is south towards the City of Fenton (not Old Gravois Road), also known as Highway 30. Take (Gravois) Highway 30 for 27 miles to Highway Y. Remember that this is a long way since you will be going through several communities and stoplights to get here. Your last 7 miles of the 27 miles is on two-lane road. Make a left on Highway Y, follow this for LESS than a mile and make a left into our facility. There will be two flagpoles a brown fence, and a mobile home at the entrance. Our office looks like a brown brick ranch house that sits a little back from Highway Y.

*Please note your last 7 miles of your 27 mile trip is on two-lane road.

From Interstate 70 (From the Airport)

Take I-70 West for 3+ miles, to Highway 270 South for about 12+ miles. Take the "Gravois Road" exit and head south towards the City of Fenton, also known as Highway 30, (not Old Gravois Road). Take Highway 30 for 27 miles to Highway Y, it only comes in on your left. Make a left, follow for LESS than one mile and make a left into our facility. There will be two flagpoles a brown fence, and a mobile home at the entrance. Our office looks like a brown brick ranch house that sits a little back from Highway Y.

*Please note your last 7 miles of your 27 mile trip on Highway 30 is on a two-lane road.

Hotel Information

There are Major Chain Hotels closest to GPS in St. Clair, MO, if coming in from I-44 from the south. Festus or Crystal City or Arnold, MO, if coming in I-55 from the south. Valley Park or Fenton, MO at I-44 and 141 from any other direction.
