Terms and Conditions: SIGNATURE REQUIRED TO TRAVEL

Deposit & Final Payment

Your payment of \$885.00 for a double occupancy room or \$1,285.00 for a single occupancy room to the League of Women Voters of Florida (LWVF) WILL HOLD your reservation. Failure to submit payment in full by at least 45 days prior to the trip may result in a loss of your spot to another traveler.

Cancellation Policy & Fees

All cancellations must be received in writing to LWVF by mail (540 Beverly Court, Tallahassee, FL 32301), by fax at (850) 222-4485, or by email at LWVFExecutiveDirector@gmail.com.

Cancellations fees apply as follow for a double occupancy room:

- 45-22 days prior to commencement of trip: \$287.63 (or 32.5% of total program price, whichever is greater)
- 21-08 days prior to commencement of trip: \$442.50 (or 50% of total program price, whichever is greater)
- 07-01 days prior to commencement of trip: \$885.00 (or 100% of total program price, whichever is greater)

Cancellations fees apply as follow for a single occupancy room:

- 45-22 days prior to commencement of trip: \$417.63 (or 32.5% of total program price, whichever is greater)
- 21-08 days prior to commencement of trip: \$642.50 (or 50% of total program price, whichever is greater)
- 07-01 days prior to commencement of trip: \$1,285.00 (or 100% of total program price, whichever is greater)

Comprehensive Travel Protection Insurance

LWVF does **not** provide travel insurance; however, you are encouraged to purchase your own travel insurance policy through a vendor of your choice. Failure to purchase travel insurance does not abate your obligation to adhere to the trip cancellation policy as outlined above.

Medical Condition

LWVF reserves the right to reject any applicant on the grounds of health. By signing below, you affirm that you are in sufficient health to participate in this program and that, to the best of your knowledge, you do not have any medical condition or ailment that would inhibit or prevent full participation.

Responsibility & Disclaimer

The League of Women Voters of Florida (the League) is responsible to you in making arrangements for travel services, including ground transportation, sightseeing and hotels, as confirmed to you. You acknowledge that the carriers, hotels and other suppliers providing these services are independent contractors and are not agents, employees or servants of the League or the League's affiliates.

The League reserves the right to accept or reject anybody as a travel participant at any time, to make changes in the travel services whenever the League deems it necessary for the comfort, convenience, or safety of the travel participants, and to cancel the travel arrangements at any time.

You acknowledge that on your visit to Upstate New York with the League you may encounter unsafe travel conditions. By signing this agreement you agree that neither the League, nor its affiliates, shall be liable for any damage, loss (including personal injury, death and/or property loss) or expense occasioned by any act or omission of any supplier providing services, or to any other person who may have a claim against the League and/or its affiliates and you hereby waive any right to any claim or damages punitive or of any kind.
