Bright from the Start: Georgia Department of Early Care and Learning (Bright from the Start) proposes to amend the *Rules and Regulations for Child Care Learning Centers* Rule 591-1-1-.36, the *Rules and Regulations for Group Day Care Homes* Rule 290-2-1-.11 and the *Rules and Regulations for Family Day Care Homes* Rule 290-2-3.11. Bright from the Start also proposes to adopt the *Rules and Regulations for Group Day Care Homes* Rule 290-2-1-.21.

Bright from the Start proposes these changes to clarify, simplify and consolidate the compliance and reporting requirements for relevant licensees in the area of transportation. Specifically, the proposed changes for Family Day Care Homes clarify areas of confusion. The proposed changes for Group Day Care Homes clarify areas of confusion and simplify rule 290-2-1-.11 by removing rules regarding transportation and creating a new rule, 290-2-1-.21, devoted solely to the area of transportation. The proposed changes for Child Care Learning Centers clarify areas of confusion, consolidate rules so that the requirements for vehicles with alarms are the same as vehicles without alarms, and simplify reporting requirements.

The proposed changes are being considered for adoption on a permanent basis, and Bright from the Start invites interested parties to comment on them.

Interested parties who wish to make <u>verbal comments</u> on the proposed rule changes may do so at a public hearing before the Board of Early Care and Learning. The public hearing will be held from 1 p.m. to 2 p.m. at **2 Martin Luther King Jr., Drive SE, East Tower 8<sup>th</sup>** 

**Floor, Atlanta, Georgia 30334** on Thursday, February 20, 2014. Speakers should sign in to speak before 1 p.m. If no guest speakers arrive by 1:30 p.m., the board will resume its regular meeting.
