Dear Parents:

Please read this letter and its attachments very carefully. The various procedures and policies will remain unchanged but is imperative you read this letter in its entirety to be sure you are not missing important registration deadlines and tuition payment dates come this August.

All families know that we will again be working with FACTS Tuition. Families who currently have an account with FACTS will be electronically reenrolled for the 2014-2015 school year. If there are any changes to your payment method and due date, please log on and make those changes. New families will be invited to set up an account via e-mail after they are enrolled in the school. If you have any questions please contact Donna Thro, the business administrator, at 233-3500.

IMPORTANT NOTE: ALL families enrolling children at St. Teresa School will use the FACTS Tuition online payment process. For your continued flexibility several payment options are available. Also, payments can be scheduled either on the 5th or the 20th of the month. If you are a family that pays tuition in advance, you will still need to go online and create an account and pay the tuition there. **Those families who pay tuition in full by August 6, 2014 or August 20, 2014 will receive a 3% discount.** No tuition payments will be taken at the school office.

Technology/curriculum fees:

Registration for the 2014-2015 school year is well underway. Paying the first technology fee for the family is considered registering. Reiterating the amounts and deadlines are as follows.

- **\$225** for 1st child with early payment reward if paid by March 31st.
- **\$250** for 1st child if paid by April 30th
- **\$275** for 1st child if paid after April 30th.
- **All final technology/curriculum fees are due on or before the first day of school.**

AGAIN THIS YEAR: To guarantee your child(ren) a spot in a class for the 2014-2015 school year, all current school families must register on or before May 30, 2014. After that date, current school family registrations will be accepted only if space is available per grade per policy. If a class is at a maximum it has been determined 5 more students will be needed in order to create a new class in that grade.
