In addition to her work with special districts, Ms. Powell assists employers and businesses with employment-related transactional matters, such as preparation of employee handbooks, employment agreements, job descriptions and identifying and preventing potential workplace disputes.

Ms. Powell regularly speaks at industry conferences including the Colorado Parks and Recreation Association annual conference, the Special District Association annual conference and the Colorado State Fire Chiefs annual conference on issues such as the Colorado Open Records Act and Open Meetings Law, the Americans with Disabilities Act, contract drafting for local governments, and the impacts of social media on employment law.
