Overview

The District of Columbia Primary Care Association (DCPCA) is the leading voice for health equity, working to support medically underserved residents in the District. We are committed to fostering collaboration among our membership to achieve collective impact, providing high quality health care to all District of Columbia residents.

There are two categories of membership: Organizational and Associate Members. All memberships are annual, and the membership year is January 1 – December 31.
