

**AMENDMENT TO THE  
AGREEMENT FOR USE OF CHURCH FACILITIES**

This Amendment to the Use of Church Facilities Agreement (the "Amendment") is made as of the 16th day of January, 2014 by and between Wellington Avenue United Church of Christ, an Illinois religious corporation ("Church") and Howard Brown Health Center, an Illinois not-for-profit corporation and its program the Broadway Youth Center ("Program").

WHEREAS, this Amendment is made by the Church and Program with the shared goal and purpose of increasing the charitable and educational use of the Church's facilities located in the building known as 615 W. Wellington Avenue, Chicago, Illinois 60657 (the "Facility") in a manner which, in the sole judgment of the Church, conforms to the goals and missions of the Church.

WHEREAS, Program has applied to the City of Chicago for a Special Use Permit ("Permit") to allow it to operate at Church; and

WHEREAS, Church supports Program's application for Permit; and

WHEREAS, Alderman Tom Tunney of the 44<sup>th</sup> Ward of Chicago will not oppose the Permit so long as the Permit is granted on a one year conditional basis and the Use Agreement between Church and Program coincides with the timeframe of the one year Permit.

THEREFORE, the Use Agreement between the Church and Program shall be amended as follows:

**Term**

The Parties acknowledge and agree that the Term of the Agreement shall now expire on March 31, 2015. Either Party shall be free to terminate this Amendment and therefore the Agreement at any time in accordance with the terms of the Agreement.

**Effective Date**

The "Effective Date" of this Amendment shall be January 16, 2014.

### Entire Agreement, Amendments, and Counterparts

There are no other changes made to the terms of the Agreement by operation of this Amendment. This Amendment taken together with the Agreement constitutes the entire Agreement between the Parties with respect to the subject matter hereof, and it supersedes all prior negotiations and understanding between the Parties with respect to the matters described herein. This Agreement may not be modified except by prior written agreement of the Parties.

This Agreement may be executed in multiple counterparts, each of which shall be deemed as original, but all of which, when taken together, shall constitute one and the same Agreement.


