Dr. Dale R. Hoyt, Superintendent of Catholic Schools, Archdiocese of Hartford

Dale R. Hoyt, Ed.D. has served ten years as Catholic School Superintendent of the Archdiocese of Hartford, CT and eight years as Catholic School Superintendent of the Archdiocese of San Antonio, TX . He spent six years as a Catholic elementary school principal in the Archdiocese of Los Angeles. Prior to that, he was an elementary and secondary Catholic school teacher. He also is a former adjunct faculty member of the University of San Francisco and St. Mary University in San Antonio, TX.

Dr. Hoyt received his doctoral degree in Education from the American International College, Springfield, MA. He received a Master of Arts in Education from the University of San Francisco, and a Master of Theological Studies from the Catholic Theological Union, a Bachelor

of Arts in Religious Education from Columbia Pacific University. He has authored several articles in various Catholic papers and journals on Catholic school education.



Camille Lewis Brown, Ph.D., Associate Superintendent for School Leadership and Community Programs, Archdiocese of Baltimore

She holds a B.A. in History from Franklin and Marshall College, an M.A. in Theology from St. Charles Borromeo Seminary and a PH.D. in Educational Administration from Boston College. Dr. Brown served in the Archdiocese of Philadelphia for eighteen years as a teacher and principal prior to moving to Rhode Island where she was the Assistant Superintendent of Catholic Schools. She has lectured on Catholic Saints, Catholic schools, Catholic Educational School Boards and contemporary educational issues. Her writings include: Glossary of Catholic Education Governance Terms, A Recipe for Change: Consolidation and Restructuring in Catholic Schools and African Saints, African Stories: 40 Holy Men and Women. Her latest article is entitled, "Vatican II called the Laity: Catholic School Boards Respond". Her current

research involves the life of St. Peter Claver and the Slaves of Cartagena. Dr. Brown founded the Bakhita Fund, a non-profit organization designed to provide educational assistance to children around the world. She has traveled extensively throughout the continent of Africa delivering health and school supplies to communities in need.
