Re: Justice Administrator

Dear County Judge and County Commissioners,

The District, County and Probate Judges of Galveston County are requesting to meet with the County Judge and Commissioners Court to discuss the position of Justice Administrator. As you are aware from recent events, there is a difference of opinion as to who has the legal authority to interview, hire, supervise and fire the justice administrator. We are aware that the Commissioners Court is considering hiring outside counsel to pursue a mandamus action to challenge the legality of the Administrative Judge's Order of September 24, 2014 directing that the process of interviewing "finalists" for the position "cease and desist."

An Attorney General's Opinion has been requested regarding the authority of a constitutional county judge or commissioners court to appoint and terminate staff assigned to perform judicial functions for the district and statutory county courts in the county. We believe, on the basis of historical fact, the State Constitution and from State statutes, that this authority is vested in the judges.

We recognize that reasonable minds can differ on legal interpretations and believe that a wise course of action would be for all of us to meet together and explore a reasonable resolution of this issue. Negotiation may save the taxpayers of Galveston County significant expense which might be expected from related litigation (prosecuting and defending a mandamus proceeding, and potential suits from the past justice administrator and/or from any future justice administrator, depending on the outcome of the AG's opinion.)

Thank you in advance for your prompt response to this request. We will do our best to be available to meet at the earliest possible convenience. Please contact Kay Henson, 56th Judicial District Court Coordinator, to facilitate setting up the meeting.
