
Special Diabetes for Indians Renewal Tool Kit

The Special Diabetes Program for Indians (SDPI) expires on **September 30, 2014!** Indian Country must stand up for this important program before it is too late. SDPI is changing the diabetes landscape in Indian Country. Today, the program supports 404 diabetes treatment and prevention programs in 35 states. Community-driven, culturally appreciate programs have led to significant advances in diabetes education, treatment and prevention.

Last fall, 75 percent of the House and Senate signed a letter supporting the renewal of SDPI – but we are not done yet! Typically, SDPI is renewed as part of the “Medicare Extenders” package that accompanies the Sustainable Growth Rate (SGR) “fix” for physician Medicare reimbursement. The Senate Finance Committee has passed a bill that would renew SDPI for 5 years at \$150 million/ year (S. 1871). However, the full Senate has not considered the measure. The House of Representatives has not considered the Medicare Extender legislation. We urge you to please contact your Representatives and urge them to **pass the SDPI as part of the Medicare Extenders.**

HOW YOU CAN HELP

- 1) **SDPI Post cards:** Postcards are a simple, cost-effective way to get the attention of Members of Congress. The more we can demonstrate that this is a program that is deeply cared about – and is getting real results – the more likely we are to see it renewed! To help NIHB with his campaign, we ask that you distribute these postcards to Tribes and SDPI grantees in your Area and have individuals fill out their name and address. - 2) **Direct Contact with Member of Congress:** Please call or email your Representatives and Senators and urge them to push for a renewal of SDPI in the Medicare Extender package on the SGR Fix. You can find your Representative by visiting www.house.gov or your Senator by visiting www.senate.gov.
- 3) **Host an SDPI Site Visit:** NIHB asks that SDPI grantees contact their Member of Congress immediately to visit their program. By doing this, you will be able to demonstrate the excellent outcomes of the program and give congressional representatives first-hand information on the importance of SDPI to their constituents. Site visits are key if we want to turn a Member of Congress from just a *supporter* into an *advocate*. - 4) **Send a letter from your Tribe:** You can also send a letter from your Tribe to support SDPI. A sample letter is below.

Dear Senator/Representative,

As a constituent and someone who knows first-hand the tremendous burden diabetes places on my community, I am writing to let you know about the lifesaving Special Diabetes Program for Indians (SDPI). Thanks to the recent Congressional reauthorization of SDPI through September 2014, my community will continue to receive the resources needed to address the disproportionate burden of diabetes. As you may know, American Indians and Alaska Natives (AI/ANs) adults are 2.3 times more likely to have diagnosed diabetes compared (compared with non-Hispanic whites) and the death rate due to diabetes for AI/ANs is 1.6 times higher than the general U.S. population. However, the federal investment in SDPI represents a significant accomplishment and is improving the health care quality and access of AI/ANs.

Today, SDPI supports over 404 Indian Health Service, Tribal, and Urban programs in 35 states. SDPI has also led to significant advances in diabetes education, prevention, and treatment.
