
HOTEL TRANSFERS / AIRPORT TOUR/ AA MRO TOUR



Presentation Descriptions for Wednesday, April 23rd:

The Last Five Years...How Did we Get Here?

Recession...check. High Fuel Prices...check. Consolidation...check. ASD...priceless! The past two years have seen the industry change dramatically. Hubs have come and gone. Airlines have merged. Fuel prices remain high as the economy continues to recover and, best of all, fares are up. Over the past two years, what fundamental dynamics have affected the air service industry to create the environment we find ourselves in today? Jack and Mark outline how we got here, and ask the question: "Have we done this to ourselves?"

The Next Two Years: Consolidation End Game / Equipment Changes / Slot Swaps

We have all heard the rumors of the impending demise of air service and the obsolescence of air service development as an industry. While challenges are ahead, now is not the time to scuttle efforts to affect positive changes in air service to your community. Over the next two years the consolidation of Southwest and AirTran will come closer to completion; US Airways will disappear. Michael will provide the evidence to quash the rumor that air service development is entering the ice age.

EAS / Equipment vs. Pilots / RJs...the Present and Future for Smaller Airports

Small markets, including those served via Essential Air Service contracts, have seen huge changes in the past few years – some positive, some negative. Michael, Greg and Josh take a look at the EAS program today, the changes in pilot rules, scope clause issues, the upgrade of equipment from regional jets to long-haul aircraft, and the continuing dilemma of small aircraft in the U.S. Where is EAS headed and, if you represent an EAS airport, what strategies and tactics should you consider to ensure continued air service?

Pricing, Revenue, Ancillary Charges and Their Effects on You

Airlines are posting record profits and fares continue to rise, but there is now simultaneous growth in fare increases and expansion of ancillary product offerings. Profitability prevails through the continued growth and expansion of these ancillary product offerings. Michael, Greg and Michael explore the changing structure of airline pricing departments and how fare increases and ancillary fees are fueling growth today (especially among legacy carriers taking advantage of new opportunities), and the future impact of ULCC's in the domestic environment.

Examples of Success / They Don't Always Show Up / Is it Worth it?

As our postcards attest, it has been a productive year for new service additions. Even in a macro stagnant growth environment, growth is still taking place on a micro level in many markets across the country. Jack and Elizabeth will share examples of air service development projects from the past year and the details and plans behind the success of those projects. Sometimes, despite everyone's best efforts, the passengers still don't show. Is it worth it? Join us for an interesting discussion on what we have learned that does, and does not, work from our two decades in business.



Presentation Descriptions for Thursday, April 24th:

Marketing / Community Engagment / Air Service Retention and Growth

As consolidation has limited the number of airlines in the domestic environment, it has also eliminated much of the competition. Due to this decreased competition, it has become even more important to sustain and grow your market from within your own community. Over the past year, Sixel has increased our focus on marketing and growth to include industry experienced air service marketing professionals. New routes are not the only routes that require attention and support. Working with various airline departments and local communities as a whole is a focus and emphasis for us and should be a focus for you. The requirements for marketing success vary between airports, communities and the types of air service in place. Elizabeth, Katie and Diana will discuss the challenges that come with marketing airports of all sizes – including understanding leakage to other airports, and the importance of community support and buy-in. This session will include case studies and methods to help distinguish your airport from competing airports while reaching the traveler during the decision making process.

International Service / Facilities / Opportunities for ASD in a Global Marketplace

What does your airport have to do to remain viable in a global environment? While the U.S. domestic industry is competitive from a DOJ standpoint, consolidation is mostly a response to intense international competition and the rise and increase in power wielded by global alliances. After 40 years in business, even Southwest is getting into the international game! Jack and Ilona will discuss the changing demographics and the reduction in global borders, and will demonstrate how they are providing opportunities to communities small and large to increase air service both within and outside the U.S.
