## PUBLIC HEARING NOTICE

The Town of Yarmouth Department of Community Development will conduct a public hearing <u>Tuesday</u>, <u>March 4, 2014</u>, at 3:00 pm in the Hearing Room of Yarmouth Town Offices, 1146 Route 28, South Yarmouth, Massachusetts. This location is handicapped accessible. The purpose of the hearing is to obtain the comments and the views of citizens, public agencies, community organizations, and other interested parties in Yarmouth on the Annual Action Plan for the Department of Community Development.

Estimated Funding Amount for Fiscal Year 2014 – Community Development Block Grant Program (CDBG) is approximately \$120,000. This amount is estimated. Actual allocations by US HUD to the Yarmouth CDBG are not available at this time. Should the actual allocation amount exceed this estimate, the activity budget for the CDBG Affordable Housing Program will be increased by the additional funding available. Should the actual allocation fall short of this estimate, the all proposed activity budgets will be proportionally decreased from the estimated funding levels to match actual allocation amounts.

Information obtained will be considered in the preparation of the Annual Action Plan for the Program Year 2014. This plan serves as the planning and strategic document for the Town's Community Block Grant Program, which is funded by the Department of Housing and Urban Development (HUD). Interested parties may submit comments for consideration in the preparation of the Annual Action Plan.
