CHAMBER BOARD OF DIRECTOR ADDITIONAL & BY LAW MODIFICATION VOTE TO BE HELD AT AUGUST 22 CONGRESSIONAL BREAKFAST

To All Chamber Members:

Please be advised that two pieces of business will be up for Membership vote at the next General Membership Meeting to be held at the Congressional Breakfast on August 22.

#1 Additions to the Board of Directors

After vetting applications received earlier this year for open Board of Director's positions, the Nominating Committee recommends adding the following new Board Members:

Aaron Crispin, owner of Print Signs and Designs, Bridgeton, NJ
Hue Grant, Architect, Hue Architecture, Pilesgrove, NJ
Louis Joyce, owner, LCJPP, LLC, Alloway, NJ.

#2 Chamber By Law Modification

The Board of Directors also recommends the following modification to Article V, Section 7 of the Salem County Chamber of Commerce By Laws.

Section 7: Vacancies. When vacancies on the Board of Directors occur between elections as a result of death, resignation, incapacity or because of absence, **the Nominating Committee will nominate a candidate to fill the unexpired term of the Director being replaced** to the Board of Directors. The nominee will be approved by the affirmative vote of the remaining members of the Board and then elected by the membership at the next Annual Meeting. A vacancy shall be filled only for the unexpired term of the Director being replaced. Filling a partial term of a vacant director shall not constitute a "term" for purposes of Section 6, above.

Shall be changed to:

Section 7: Vacancies. When vacancies on the Board of Directors occur between elections as a result of death, resignation, incapacity or because of absence, **the Nominating Committee will nominate a candidate to fill the unexpired term of the Director being replaced** to the Board of Directors. The nominee will be approved by the affirmative vote of the remaining members of the Board and then elected by the membership at the next General Membership Meeting. A vacancy shall be filled

only for the unexpired term of the Director being replaced. Filling a partial term of a vacant director shall not constitute a “term” for purposes of Section 6, above.

Membership voting on both recommendations will take place on August 22, 8:30 am at The Congressional Breakfast to be held at Ranch Hope Cafeteria, Alloway, NJ.

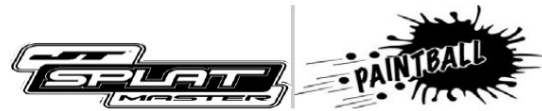

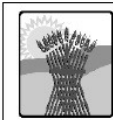
